- <u>INFORMATION/DISCUSSION/ACTION</u> Title: 2021-2022 DASG Budget Stipulations *This item is to discuss and approve the 2022-2023 DASB Budget Stipulations*. Presenter: Sharon Utomo Time: 20 minutes
- $\Rightarrow$  Dennis S: Budget stipulations are not finalized until after 2<sup>nd</sup> Senate Vote, so finance committee does not have to complete today. Date changed/updated to 2022-23.
- ⇒ Lisa K: Noticed DASB to DASG correction. #13) Disability Support Programs & Services (DSP&S) and Cross-Cultural Partners received no funding this year so the stipulations do not apply.
- $\Rightarrow$  Sharon U: #11) Meals, beverages, etc will not be reimbursed?
- $\Rightarrow$  Lisa K: For speakers only.
- ⇒ Hyon Chu B: Not in any code that there is a limit for budget speakers, only DASG established limits?
- $\Rightarrow$  Dennis S: Yes.

- ⇒ Hyon Chu B: Most speakers ask for \$1500-2000. Split cost in past because of this stipulation. Will not be able to get anyone besides local or consultant.
- ⇒ Sharon U: If speaker is worth more, then DASG can waive this stipulation for special scenarios. #15) What is the DASG Student Resource?
- ⇒ Dennis S: Student Resources Day is event fair with every on-campus resource information booth but virtual version recently. Changed the word day to event.
- $\Rightarrow$  Alexander J: Should we define eco-friendly? Broad term.
- $\Rightarrow$  Dennis S: Meant to be broad term.
- $\Rightarrow$  Mohamad E: Are we still doing the movie ticket program next year?
- ⇒ Lisa K: Yes, we have a lot of movie tickets in our safe that need to be sold. Used to be very popular, so we had to limit it to 10 tickets. We used to sell a lot of movie tickets but much less due to fewer students and streaming services
- $\Rightarrow$  Alexander J: Are they still being sold?
- $\Rightarrow$  Lisa K: Yes, if you have your DASG Card.
- ⇒ Sharon U: Add "Maximum of" to #28). Keep this law in the bylaws; hopefully being on campus 2022-23.
- ⇒ Dennis S: Print issues of La Voz have not been in circle since pandemic. Change of #32) La Voz DASG members to constituents.
- $\Rightarrow$  Peter T: La Voz has advertising space for DASG, been unused since we have not sent them anything.
- $\Rightarrow$  Sharon U: Bring this issue up at Senate Meeting to Marketing and Communications.
- $\Rightarrow$  Ivy S: Why are we limiting what programs can spend on? Stipulations #35 & #36.
- ⇒ Sharon U: Certain programs have broad purposes, and we want them to fit them in categories DASG wants.

- $\Rightarrow$  Dennis S: They've been adjusted within DASG budget.
