Subject: Smoking Survey- De Anza Students 2016

The Smoking Survey for De Anza was distributed Winter Quarter 2016. Of the 3,177 students who were sent the survey, 345 completed the survey for a response rate of 11%. The important highlights include:

- 62% of students reported they have never been a smoker/tobacco user. (Question 6)
- 72% of students did not know that Health Services has a tobacco cessation program.
 (Question 8)
- 33% of students said they "occasionally" encounter second-hand smoke on campus.
 (Question 9)
- 65% of students say they encounter second-hand smoke either in student parking lots or when walking through/near designated smoking areas. (Question 10)
- 50% of students said they are worried about health exposure to smoke. (Question 11)
- 52% of students responded "yes" a smoke-free campus policy does reduce smoking on campus. (Question 14)
- In two surveys conducted, one in Fall 2011 and another Winter 2016, both reported
 12% of students never encounter second-hand smoke. (Question 9)
- Compared to the survey conducted in Fall 2011, 31% of students responded that the smoke-free campus policy is "Not enforced at all", while in Winter 2016, 19% of students responded that the smoke-free campus policy is "Not enforced at all".
 (Question 15)
- In a similar survey conducted in Fall 2011, 58% of respondents said they want the campus to be 100% smoke-free, while in Winter 2016, 46% of students said they wanted campus to be 100% smoke-free. (Question 18)





Question 19- Please let us know if you have any suggestions.

We need to be respectful for everyone, not just those that complain the loudest. I am tired of everyone thinking they know what is best for everyone. Though I have never been a smoker in my entire life and I don't like the smell, I still respect someone else's rights to make their own choices.

100% smoke-free on campus is indeal; however, I understand it could be difficult for some who are addicted to some forms of smoking. So, I don't mind if there is a designated smoking area. Just strictly enforce it, and nowhere else.

Big signs would be a great addition to have in designated smoking areas. Also, having signs throughout campus that directs smokers to designated smoking areas would be great as well so that we can have a smoke free campus.

By enforcing a smoke free environment it will allow those that want to quit smoking a chance to do so. A friend of mine told me this when San Jose State University went smoke free. He is now 1 year smoke free. I believe that is enough if it can change one person's life.

Due to limited resources, I understand how difficult it is to enforce non-smoking policy. However, the school has no problems enforcing parking rules. Is it because it is a revenue-generating scheme but the non-smoking policy is not? What's the consequence of smoking in non-designated areas? There are no posted or known consequences of violation, so the policy is not well enforced. And the lack of a revenue-generating scheme goes to the issue of motivation to enforce.

E-cigarettes, I believe, are ambiguous in the minds of many students. They feel that it doesn't fall under the things that can only be smoked in certain areas. I believe, there should be clear signs for the public so that it is clearly visible to all the e-cigarettes are also only allowed in designated smoking areas, and I think a greater effort should be made to enforce it. Teeth behind the policy is the only thing that will make people follow the rules. I believe that while smoking is unhealthy for both those doing it and those around them, as long as a smoker has not committed to ceasing, they need a place to smoke otherwise it'll motivate them to break the rules and smoke anywhere.

E-cigs should be subject to the same rules as the "usual" cigarettes. I've seen people use them away from designated smoking area, and heard them excuse it as non-harmful and not smoking.

Even if there is designated places for smoking, I tend to walk by almost everyday and that doesn't make it any less for second hand smoke.

Even when students smoke in designated areas the smell can stick to their clothes and can bother other students while in the classrooms (especially the smaller ones with less ventilation). Students who do smoke on campus should be encouraged to not smoke before class time.

I go by the smoking area at least once a day and don't really get whiffs of smoke. I think more kids vape. Also, sadly, this is one of the few places I see people hanging out. If people want to smoke, that's their problem. I'm not the type of person to tell them to stop. But also, if you did make it a true 100% smoke free place, a smoker should be able to go by a few hours without smoking so I don't think I'd be a huge issue if you made the whole campus non smoking. Just don't take anything else away from us!

I have lung problems and am disturbed seeing more smoking at school than in any other place in the Bay Area

I only have one class there so I dont see anyone smoking, but in my opinion its one of the worst things you could do to yourself and others and should be illegal to do it where anyone else could be affected by it

I personally experience the smell of smoke and marijuana in the parking lot near the swimming pool. I do have night classes. There is also drinking in the cars as well 1-3 students together. I have seen this on more than two occasions. My classes are Tuesday/Thursday 5-930. It scares me because the times I have witnessed it, the students are also driving and changing paring spots. Tha isn't safe, someone could get hurt.

I think college is very stressful and more so for people who are smokers. It's good for them to have a place to smoke. If you made the campus 100% smoke free, they would still find a way. The cigarettes butts really bother me, especially because they are always lying right next to the ash trays that are provided.

I think having a smoke free campus would cause more students to ditch class or arrive late because they have to leave campus to smoke. The current designated smoke spots allow people to get it out of the way assuming some are addicted, and allow others simple access to whatever pleasure they derive from smoking.

I think since smoking cigarettes is legal in the United States, students, who are put under extreme amounts of stress and pressure through de anza's advanced curiculum SHOULD be allowed to smoke in designated areas. During the break in my Chem 1b class sometimes it feels nice to take a break and smoke a cigarette. This is a COLLEGE not a high school and I for one do not want to be treated like a degenerate for smoking a cigarettes once every 2 weeks in my car in the parking lot. I have NEVER seen ANYONE smoke on de anza campus(besides parking lot and designated areas). Individuals who are attending college are usually 18 or older. Which means they have every right to partake in smoking. If students are offended by smoke, they should simply stay away from designated smoking areas, Like for example the ENTIRE DE ANZA CAMPUS. If I receive a ticket for smoking in my car in the parking lot it will make me feel like I can't win at de anza because not only are the classes the hardest in the state now I can't EXCIRCISE my rights as an adult on campus. I go to school and work to feel like an adult NOT a minor. End of story

I think smoking and vaporizers should be permitted but limited to designated smoking areas.

I think the policy is fine the way it is. I don't think I've ever seen someone smoking outside of the smoking area, although I have seen people vaping. I don't believe second-hand vapor is a health issue, so it doesn't bother me.

I think the system works well as it is today (for three years, I've never seen anyone smoking outside the smoking areas). My only suggestion is a fine for smoking outside the designated areas and another fine for dropping cigarette butts on the ground. There's no excuse for dropping them on the ground when there are plenty of ash trays at the smoking areas on campus.

I think we have bigger problems than this. A non-problem, in my mind.

We have Whole Foods, Trader Joes, and other health conscience companies in our community and it would be nice to come to campus and not have to walk through a cloud of smoke. I walk to class and a student is puffing and blowing in my air direction. The fact that there are designated smoke place is saying it is ok to smoke at DeAnza. Thanks for hearing my opinion

I will smoke rather or not this accurs. We are not in highschool or middle school we are grown adults.

I would only encourage a smoke-free policy for indoor locations only, but painfully financially punish people who litter and leave smoking artifacts on the ground or anywhere else for that matter.

I would prefer to have a 100% smoke free however, I know how hard it is to stop smoking. I think it's fair to have non-smoking areas, even though I personally can't stand the smell.

i'd love to go to a smoke-free campus.

If there is no smoking on campus or parking lots, then where shoud i go to smoke? driving my car go to outside of campus? during my class breaks, i usually go far way to the smoking area, it already bothered me because the long road i have walked. If you want to be 100% smoke-free, i'd rather go to other colleges than DeAnza.

If you close the smoking areas, cigarette smoke is going to be spread all over the school. Smokers are gonna smoke anyway, prohibition never worked. Compared to if we keep the smoking areas where all the smoke is concentrated and easily avoidable by simply not walking straight through the smoking area. If it's hard to avoid a circle of smoke, then I'm not quite sure what's wrong with you.

Increase the fines for smoking. VTA bus stops have a \$250 fine for second offenses for smoking.

Its bothersome to have people who go out and smoke during class breaks and when breaks are over, they come back in and sit in front of you with a bad smell.

I've taken the last couple quarters online, so I haven't been on campus as much as I used to be. However, I have always been impressed with the structure and proper usage of smoke areas. There are always a few exceptions of people who don't know or follow the rules, but that will happen even if the entire campus was smoke free. As a former smoker, I understand why these zones are important to some people. As nice as it would be to have a smoke-free campus and having everyone quit, that is not realistic nor fair. Perhaps enforcement to stay in designated areas needs to be increased.

Keep it the same, students who smoke sometimes need a cigarette to deal with stress of school. 100%smoke free might have students who use cigarettes upset and reduce their productivity.

Let people do their thing, it's a big campus!

Make it more clear how much you are willing to help and how easy getting help can be. Focus on the quitting more than the designating. No support and no money to help quit stops a lot of young people from considering it.

Making it expensive, inconvenient and uncool will kill tobacco use. Fines and taxes make it expensive. Make it a preclusion for financial aid. Moving it off campus makes it inconvenient but then they smoke in the lnearby church and business lots. Make it a school offense to use use in lots that neighbors also disallow. Make it uncool by not allowing athletes to use.

More designated smoking areas

More designated smoking areas near entrances and parking lots

Nice how you don't ask any questions regarding whether people feel the smoking policy is wrong, or what areas it could be changed or improved. Or if survey takers agree with your policy regarding vaporizers/e-cigarettes. Typical way to let a minority interest group cement silly rules, such as those for vaporizers. Great to know I can quit smoking cigarettes after 20 years and am forced to go hang out in the smoking area for a vaporizer. Major fail with a survey disguised to support students on campus

No grey lines, bank all smoking

Often times, smokers walk into class, smelling like smoke. This bothers me to immensely and I find it harder to focus in class whenever this happens. The designated smoke area should be further away from building and be more regulated.

People need to get over anti-smoking. Let people smoke and if you don't like it walk around the smoking areas. If you walk around it you will not encounter second hand smoke. Simple as that. Problem solved. People make a huge deal about second hand smoke when a bigger problem is everyone and their skateboards and those hover board things. They need to watch where they are going. Leave the smokers alone.

Personally I think smoking areas should have shaded areas. Also information about resources and services to help quit smoking should be available at each smoking area.

Please do not make the campus 100% smoke-free. The students and faculty who smoke should have the right to do so. Current smoke areas are easily avoidable and a good alternative to eliminating areas for people to smoke if they so choose to do so.

Please make it clear to all students that e-cigarettes / "vape pens" are not allowed to be used within the campus. By not enforcing this, students are taking advantage of these devices on campus, forcing non-smoking students to walk through and inhale the large clouds of "vapor" they blow around. Some of the fluids used in these "vape pens" contain nicotine, making these occurrences even worse.

Please put roofs over the smoking areas. The rain bothers students a lot and banning smoking areas is not an option. People have different needs and it is their choice to smoke or vape. Smoking areas are a good idea but they are not very inviting and I can see why someone would rather be in the shade by a tree outside of the smoking area. Better smoking areas with a roof will make a cleaner and more smoke free campus than banning smoking altogether because let's face it, a simple law will not stop people and possibly make it worse as it did in Northeastern for example.

Post Signs and Enforce Regulations

Rather than having designated areas for smoking, prohibit smoking directly near other people (4-6 feet) and in areas of frequent student usage (parking lot, classrooms, etc.).

School should support non-smoker who does not want to obtain the health problem such as long cancer.

Simple Fines \$ no excuses once lit \$25 per incident. Paid to get grades 2nd time higher. Not sure what it is now but threshold should be lower if everyone gets them vs warnings. Immediate fine spreads the word faster among smokers.

Smoke weed

Smokers trail their tobacco residue into classrooms on their clothing. It doesn't matter that they smoke outside--they bring secondhand smoke into every class they attend.

Smoking education tailored for international students.

Smoking is an issue between students and their parents. By the time a student reaches DeAnza their habits will be set either way. Please don't waste my tax dollars and tuition trying to fix what not even their parents could. As far as second hand exposure is concerned the current designated areas are sufficient. The rest of us don't mind the exercise it takes to walk around them. Those that do should also grow up. Less administration, more teaching please. I don't like paying for non value added overhead.

Smoking is the least of our problems on both of these campuses. Let 'em smoke. How about better instructors and more counselors? That's a start.

Smoking reduces stress levels. If you take away smoking, those who do smoke will be more frustrated and distracted. Have you ever needed to have a quick smoke because you are having a hard time understanding something? Try having to walk 10 mins away to spend 5 smoking and 10 mins back. You would miss half your class.

Smoking should not be aloud anywhere. The designated areas especially near the pool and forum buildings are used to smoke Tobacco, do drugs, and drink alcohol be student as if it was a place to party. A police officer needs to be posted there at all times.

Smoking tobacco products needs to be discouraged as much as possible and by eliminating smoking at DeAnza is send a clear message. Smoking tobacco is in my opinion a legal drug. It causes severe health problems including addiction and has very severe withdrawal symptoms when a person tries to quit. So all of these factors add up in opinion to a legal poisonous substance that is allowed to be abused by its users so I call the tobacco users addicts and the tobacco companies drug dealers.

Some of the kids that smoke in the smoking area are sorta creepy sometimes. Maybe have these smoking areas watched a bit more?

Some people thinks that e-cigarette is okay to smoke anywhere on campus. It's smoke and smell is same as second hand smoking. People should know that vaping is also smoking and should be only used on designated spots. I feel very annoyed by people who are vaping in the campus. The smell of any kind of smoking is hurting my head. Also the smoking areas should be far from the entrance of the campus. I mean everyone who are going into the campus is experiencing second hand smoking.

Start fining people that smoke away from the designated areas

Students should smoke outside school grounds and if caught, either the student gets a violation toward their academics or be fined.

Thanks for continuing to crack down on smokers. Smoking is one of the most invasive and inconsiderate forms of damage done non-consensually to others.

The less smokers we have on campus the better students will enjoy it overall.

The one suggestion I have is to create more smoking sections in the parking lots to keep the students away from trying to smoke it in the hallways or other common areas.
