

Foothill Bookstore Plan

- Extend current contract with Follet through June 30, 2027
- By Spring 2026, transition to fully online bookstore model
- Course materials mailed directly to purchasers' home address
- Pick-up option available at Campus Welcome Center
- FHDA conducts an RFP process during Winter/Spring 2027 for both colleges
- New FHDA contract finalized by June 30, 2027

De Anza Bookstore Plan

- Extend current contract with Follet through June 30, 2027
- DO NOT transition to online bookstore model during the extension period to avoid disruptions during the academic year
- Conduct campus-wide dialogue during Fall 2026 to gather input on future bookstore services and needs
- FHDA conducts an RFP process during Winter/Spring 2027 for both colleges
- Review, select, and negotiate with new vendor
- New FHDA contract finalized by June 30, 2027

- Offers catering & online ordering


