

## WELCOME TO CRIME AND CRIMINOLOGY

### **COURSE DESCRIPTION**

This course is designed to introduce you to the field of criminology, providing an overview of the issues involved in defining, measuring, and explaining crime. You will learn about the field of criminology, examine general characteristics of crime and criminals, review early and contemporary theories which attempt to explain criminal behavior, and discuss crime in the modern world.

### **COURSE OBJECTIVES**

- 1. Identify and describe the origins of the criminal justice system and the study of criminology.
- 2. Discuss and compare the biological, physical and sociological perspectives of criminology.
- 3. Examine and evaluate and individual's reaction to involvement in criminal behavior.
- 4. Explore and evaluate the ideological approaches to solving crime.
- 5. Discuss and explore practical aspects of the criminal justice system through instructor and guest lectures

#### STUDENT LEARNING OUTCOMES

- 1. Analyze the historical nature and measurement of criminal behavior within society.
- 2. Identify and compare the biological, psychological, and sociological explanations of crime.
